



With the expected confirmation of Gary Gensler as chair of the Securities and Exchange Commission, I expect to see a more pro-enforcement agenda that will both continue the focus on protecting Main Street investors while also expanding scrutiny of Wall Street firms' conduct. Gensler, whose tenure as Chairman of the Commodity Futures Trading Commission during the financial crisis was viewed as aggressive and influential, is likely to return to a "Broken Windows" strategy by bringing an increased amount of cases against regulated firms and individuals involving minor violations and non-fraudulent conduct. Other priority areas are expected to include virtual currencies, insider trading, FCPA, and disclosure issues. It will also be interesting to watch how the Commission continues to review and enforce compliance with Regulation BI, which went into effect in June 2020.

#### Hal Levenberg Chapter Membership

On January 1, 2020, the chapter had 93 members. Increasing our membership has proven challenging in the remote/online environment of Covid-19. However, as of today, the chapter has 200 active members. We have increased the chapter membership 115% in 2020. We are looking to continue to grow our membership and cannot wait to be able to interact with the membership at training and events in the future.
